Here are some things you need to know:

A CHILD is a person below the age of 18.

PARENTS are people who give birth to or adopt a child and takes care of him/her.

Your father and your mother are your parents.

GUARDIANS are care-givers who take care of children that are not theirs.

Your RIGHTS are what you deserve no matter who or where you are.

The CHILD'S RIGHT ACT is a document that promotes and protects the rights of the Nigerian child.

Your rights fall under the following categories;
Survival Rights
Protection Rights
Development Rights
Participation Rights

SURVIVAL RIGHTS

My survival right is to live a healthy life and grow into a strong and capable adult.

My survival rights include:

Right to life.

Right to good health.

Right to immunization.

Right to nutrition.

Right to Health and Health Care Services

I should enjoy the best physical, mental, and spiritual health from the day I am born.



Right to Nutrition

I have the right to have healthy meals. I should eat vegetables and other foods for adequate nutrition. This helps me grow strong and healthy.



PROTECTION RIGHTS

All decisions that affect me must be taken in my best interest and protect me from harm such as:

Indescent and inhuman treatement, Sexual exploitation,

Drug abuse,

Child labour,

Torture,

Maltreatment,

Neglect,

Discrimination,

Trafficking.


Right of Unborn Child to Protection

A child should be protected from any form of harm before, during, and after birth.



Right to Name, Identity, Nationality, and Birth Registration

I should ask my parents or guardians if my birth is registered.





I have the right to a registration of birth and to be identified by a name and nationality.


Right to Dignity as a Child

I should not be subjected to physical, mental, emotional, or sexual abuse.



I should not be injured, maltreated, or neglected.

I should be corrected with love and care.



Prohibition of Child Marriage / Betrothal



I should not be betrothed to anyone as




I should not be decieved or forced into marriage.



Prohibition of Tattoos and Skin Marks

I should not be given tattoos, facial, and skin marks as these are dangerous to my health.



Prohibition from Drug Abuse

Hard drugs are very dangerous to my health.







I should be protected from any form of drug abuse including its use, sale, and trafficking.

Prohibition from use for Criminal Activities



I should not be employed or used for criminal activities such as stealing.

Prohibition from Abduction, Removal, and Transfer from Lawful Custody



Prohibition from Exploitative Labour



I am not supposed to do any work that will affect my education, health, and social life.


Prohibition from Buying, Selling, Hiring or Dealing in Children for...



Hawking

I should not be used for begging, hawking, or prostitution.

Prohibition from any form of Sexual Abuse with a Child



The places marked 'X' are my private parts (bum-bum). No body should touch them.

Prohibition from any form of Sexual Abuse with a Child



I should not be exposed to materials with any sexual content. I should not involve myself with any form of media not suitable for my age.

DEVELOPMENT RIGHTS

In order to become a good adult, I have to exercise my rights to development as a child.

My development rights include:

Right to compulsary Universal Primary Education.

Right to leisure and participation.

Right to Education



I have the right to go to school. It is my responsibility to study well and get good grades.



PARTICIPATION RIGHTS

Right to freedom of association and peaceful assembly.

Right to freedom of thought, conscience, and religion.

Right to privacy and family life subject to parental guidance.

Right to freedom of movement subject to parental guidance.

Right to rest and leisure and to engage in activities suitable for my age subject to parental guaidance.

Participation Rights

I have the right to take part in activities and decision making that affect me.



I can express my opinion on different issues and I should not be afraid to share the ideas that I have.

Participation Rights



I can have friends.

I can join clubs and associations if my parents or guardians approve of it.

Right to Freedom of Thought and Worship

I can think, follow my mind, and worship God anywhere.






Right to Privacy and Family Life

I should have a home and family life. I can have privacy and communicate with people.



But my parents and guardians have the right to supervise and control my conduct.

Right to Freedom of Movement



I am free to move around as long as I seek my parents or guardians permission first.

Right to Recreation



I can play and involve in sports.

I can be involved in cultural activities as my parents or guardians guide me.
